Pensions for Purpose Paris Alignment Forum

The increased interest in climate action has gained significant momentum among pension funds and other asset owners over the past twelve months. This has been spurred on by changing regulations and the government's desire to mandate TCFD-aligned disclosures across the economy by 2025. Yet many pension funds are struggling to work out the most effective way to change their investment strategies to move towards Paris-Aligned or net-zero goals without conflicting with their fiduciary responsibilities. At the same time, across the investment chain, all parties are setting goals (asset managers, companies) but we need to make sure that we are speaking in the same language and with the same universal aims to make this shift purposeful.

Pensions for Purpose is already working with pension funds to help them on their journey towards Paris Alignment. We do this by sharing climate-related thought leadership written by our Influencer members (asset managers, consultants and lawyers), by running workshops for trustees to help them articulate their investment beliefs and climate goals, and by organising "Afternoon Tea" small group discussions on relevant topics.

Building on the help already offered to pension funds, we shall be launching a new "Paris Alignment Forum" in Q2 2021, to begin an industry-wide conversation on this important topic. The Paris Alignment forum will offer a quarterly cycle of:

- Keynote presentations and subsequent small group discussions
- Training opportunities
- Peer-to-peer meetings for pension funds and other asset owners to share experiences, discuss challenges and learn from other asset owners
- Opportunities to connect with climate action experts such as the IIGCC
- Signposting to relevant content on our platform
- Afternoon Tea discussions
- Quarterly newsletters with relevant updates and information.

Our aim is to bring together different stakeholders including pension funds, independent advisers, asset managers, consultants, lawyers, government representatives and climate experts, to facilitate an informed and helpful conversation on this important topic.
