



TISFD Supporter FAQs

What is the TISFD?

The Taskforce on Inequality and Social-related Financial Disclosures (TISFD) is a global initiative that will develop a set of recommendations that enable companies and investors to identify, assess, and report on their inequality and social-related risks, opportunities, and impacts. The aim of this initiative is, ultimately, to strengthen the stability of financial systems, address the systems-level risks posed by inequality, and improve outcomes for all people.

What is the TISFD Working Group?

The TISFD is being developed by the TISFD Working Group and will be launched in September 2024. The Working Group is a multi-stakeholder collaboration between a diverse set of more than 20 organisations across the public and private sectors.

Who can become a TISFD Supporter?

Any organisation interested in supporting the launch of the TISFD can become a TISFD Supporter. The TISFD will engage with a broad range of civil society groups, investors, businesses, financial institutions, academics, and governmental organizations. Individuals interested in supporting the Taskforce are encouraged to join the TISFD LinkedIn Group where more information will be shared on how to engage with the Working Group and Taskforce.

What does it mean to be a TISFD Supporter?

Organisations that sign up to be a TISFD Supporter acknowledge the importance of strengthening the development of financial disclosures regarding inequality and social-related issues and are supportive of the creation of a Taskforce to lead on this work. Supporters will help provide a broad range of input into TISFD, which will help ensure that its outputs are well-received and used in the market.

Joining as a Supporter is not a direct endorsement of any potential outputs of the TISFD. Supporters will periodically receive updates to learn more about the TISFD Working Group and opportunities to engage. Following the launch of the Taskforce in September 2024, the TISFD Working Group envisions that there will be several ways for Supporters to engage in the development of the framework.

How can Supporters signal or showcase support of the TISFD?

TISFD Supporters can support the launch of the Taskforce by participating in a range of activities, depending on their level of interest and ability to engage publicly. Potential activities include:

- Submit logo/name to be added to the TISFD website under a 'Supporter' section header
- Promote the TISFD updates via relevant Supporter-owned channels (e.g., LinkedIn, newsletter, website, etc.)
- Provide feedback via public consultations
- Participate in TISFD webinars
- Complete periodic surveys
- Sign up for the TISFD newsletter
- Invite others to support the TISFD
- Engage formally with the TISFD once launched in September 2024
